### Deposit

A non-refundable deposit of \$600 per person must be paid to Bridget Gallagher's at the time of the booking to hold your reservation. The company must receive the balance no later than 60 days prior to departure. Where reservations are made less than 45 days prior to departure, full payment of deposit and tour charges will be due immediately.

### Cancellations

The company reserves the right to cancel the tour where the minimum number of passengers required is not met. In such cases the limit of the company's liability to the passenger is the return of any monies paid by the passenger. In the event of cancellation by the Company, the Company will endeavor to provide a minimum of 8 weeks notice. Where the passenger cancels the tour reservation the effective date of cancellation will be the date on which the Company receives written notification of the Passengers' intention to cancel their tour reservation. In the event of cancellation by the passenger, a cancellation charge calculated on the scale below shall become immediately payable by the passenger. *Airfare is non-refundable.*
